WHEREAS THE SETTLOR above named has been created and established on 05-11-2015, a public charitable Trust for General public charitable purpose and public welfare purpose objects creating facilities for the benefit of society at large more specifically objects and purposes to social development, Child development, Education, Cow Welfare, Cow shelter, Cow protection and welfare of needy persons of society and sustainable development.

Trust was registered under The Rajasthan Public Trust Act, 1959 (42 of 1959) with office of assistant commissioner, Devsthan department, Udaipur by allotting a registration number 27/TRUST/DEV/UDAI/2024 on 28-03-2024.

AND WHEREAS THE SETTLOR& TRUSTEES desires to add /amend /alter /remove/ replace /modify/change/delete the following clauses/sub-clauses/sentences/words in the clauses of original registered trust deed executed between settlers and trustees of **SHREE HARI GAU SEWA SANSTHAN**.

THIS INDENTURE WITNESSETH AS FOLLOWS:

11.0 That without affecting generalities of power and functions of the trustees, to manage and administer the trust and for the furtherance of the objects the trustees shall have the powers:

In the aforementioned Sub-clause (a) of Clause 11.0, the words '*national or international agencies, foreign Person, foreign individual(s), foreign government, foreign institutions, foreign trusts, any foreign body, NRI in India and abroad under the prevailing law at that time in India, shall be added.*'

The Sub-clause (S) of Clause 11.0, of the Original Registered trust deed, titled "POWER AND FUNCTIONS OF THE TRUSTEES ARE AS FOLLOWS" states that, 'To apply to the government, public bodies, urban, local, municipal, district and other corporation, companies, organizations, agencies or persons, ***national or international agencies, foreign Person, foreign individual(s), foreign government, foreign institutions, foreign trusts, any foreign body, NRI in India and abroad under the prevailing law at that time in India,*²*** for and to accept grant of money and of aid, donations, gifts, subscriptions, lands and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the government departments, public and other bodies, corporations, companies, organizations, funding agencies, support agencies or persons, ***national or international agencies, foreign Person, foreign individual(s), foreign government, foreign institutions, foreign trusts, any foreign body, NRI in India and abroad under the prevailing law at that time in India,*²*** scheme and other work and matters within the objects of the trust and to confirm to any proper condition upon which such grants and other payments may be made.
