And whereas the Trustees have, at the request of the settler, agreed to act as the first Trustees of these presents as testified by their being parties to and executing these presents.

And whereas it is necessary to declare the objects and terms of the public charitable Trust, being constituted under these presents.

Now this indenture witnesseth as follows:

1. That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the Trustees, a sum of Rs. 1100/- (Rupees One Thousand One Hundred only), hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the Trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents, and the Trustees shall hold and stand possessed of the same upon the Trust subject to the powers, provisions, agreements and declarations hereinafter contained.

2. That the name of the Trust is **Shree Hari Gau Sewa Sansthan** and its principal registered office & Gaushala for the present, is situate at 28, Nandeshwar Colony, Kalka Mata Road, Pahada, Udaipur – 313001. **Administrative Office – 8, Nada Khada, First Floor, Inside Bapu Bazar, Udaipur (Raj.) 313001.** The registered office can be changed by the Board of Trustees. The administrative office can located be at any place and at other cities/parts of India. The registered and administrative office(s) can be changed by the Board of Trustees.

The administrative office(s) and Branch office(s) of the trust can be established at Rajasthan, Delhi, Mumbai, Haryana, Uttar Pradesh, Uttarakhand, Maharashtra, Gujrat and all states and union territories of India and/or at any such other place or place in India as the Trustees may decide from time to time.

3. That the objects for which this Trust is established are:

3.1 Save Cow Programmes and Cow Shelter Houses (Gaushalas)

1. To work, manage, run, support and undertake programmes, projects and activities for the welfare, protection, shelter, treatment, care of the cows.
2. To Form, run, establish, manage and support Cow Shelter House (Gaushalas) in Rajasthan, Uttar Pradesh, Uttaranchal, Haryana, Punjab, Delhi, Madhya Pradesh, Gujarat, Maharashtra, Chhatisgarh, Bihar, Jharkhand and other states of India.
3. To arrange shade, shelter and fodder and attend rescue calls for stray animals cattles especially Gaushala for cows and the breed helpful in Farming and Dairy products. It ultimately will help to generate employment in rural Dairy and Farming sector and will empower the economy of rural areas.
4. To conduct, help and collaborate for national and international level trainings, seminars, symposia, workshops, conferences, lectures etc. on the programmes and activities concerned with cow welfare programmes and related objects.
5. To undertake cow welfare activities and to advocate banning of cow and animal slaughters.
6. To provide basic veterinary services, including ambulance services for cows.
7. To set up cow hospitals and cow care centers.





3. To establish, maintain, run, grant, pay or give scholarship, studentships, stipend, prize, rewards, allowance, loan and other financial assistance or help in cash or kind to deserving students with a view to help them in pursuing their studies in college, educational institutions, technical institutions, art schools, institutes commercial and other arts including teaching of cultural arts or other training, research or educational work in India or abroad that may be useful.
4. To provide career guidance, employment support and render assistance, scholarship loans, grants, prizes, books and other article for educational purposes.
5. To promote and to develop vocational education in the educational institutions leading to self-employment and better employment opportunities.
6. To operate, run, support, manage training centers, training institutes, coaching centers, coaching institutes, employment centers, educational institutes and other operations, campaigns, activities and programmes related to training, provide







35.0. The area of operation of the Trust shall be all over India, International level and abroad according to decided and applied rules and laws of Government of India for Trusts/NGOs.

36.0. Trust can open/manage/operate offices at international level and abroad (outside India) to support its objects, programmes, projects and activities. The rules and laws of Government of India shall be applicable to manage and operate the offices and support the objects and programmes of Trust; and the Trust shall follow and work under the rules and laws.

37.0. The Trust can open bank accounts anywhere in India, including Delhi, Mumbai, Gurgaon and in all other cities of India; in the states and territories of India as Delhi, Uttar Pradesh, Haryana, Punjab, Chhattisgarh, Madhya Pradesh, Uttarakhand, Rajasthan, Gujarat, Maharashtra and in all states and union territories of India and/or at any such other place or places in India as the Trustees may decide from time to time.

38.0. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly. No part of the Trust income or assets is transferable, or to be applied for any purpose other than charitable purpose.

39.0. The details of movable property of the Trust are Tin shade covered in Gaushala 33 Nos. of Tin size 16 x 3¼ Ft. & the total value of above on the date of Registration 20.11.2023 is approx 1,50,000/- Rs. in words One Lac Fifty Thousand Rs.
